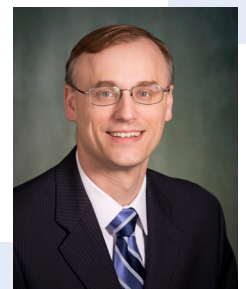
trusts and estates practices, or other transactional practices.

# MICHAEL GERSON



Michael J. Gerson is a nationally syndicated columnist who appears twice weekly in the *Washington Post* and in more than 100 other newspapers. Mr. Gerson is the author of *Heroic Conservatism* (HarperOne, 2007) and co-author of *City of Man: Religion and Politics in a New Era* (Moody, 2010).

Until 2006, Mr. Gerson was a top aide to President George W. Bush as Assistant to the President for Policy and Strategic Planning. He was a key administration advocate for the President's Emergency Plan for AIDS Relief (PEPFAR), the President's Malaria Initiative (PMI), the fight against global sex trafficking and funding for women's justice and empowerment issues. Prior to that appointment, he served in the White House as Deputy Assistant to the President, Director of Presidential Speechwriting, Assistant to the President for Speechwriting and Policy Advisor. Mr. Gerson joined Bush's presidential campaign in early 1999 as Chief Speechwriter and a senior policy adviser.

He was previously a Senior Editor covering politics at U.S. News and World Report. Mr. Gerson was a speechwriter and policy adviser for Jack Kemp and a speechwriter for Bob Dole during his 1996 presidential campaign. He has also served former Senator Dan Coats of Indiana as Policy Director. Mr. Gerson is a graduate of Wheaton College in Illinois. He grew up in the St. Louis area and now lives with his wife and sons in northern Virginia.

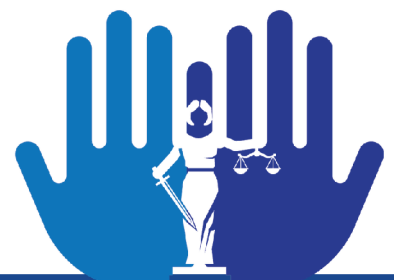

## VIRGINIA BEACH CIRCUIT COURT PER CHIEF JUDGE, THE FOLLOWING POLICY IS EFFECTIVE MARCH 1, 2019:

To comply with Code § 16.1-296(D), the initial trial date in a termination of parental rights appeal case shall be set within 90 days of perfecting the appeal. The Clerk of Court shall contact the City Attorney for an available date. Preferably on a Thursday. It makes no difference if the Court's docket is "full". The Clerk of Court shall then send notice of the trial date to the all counsel of record and any pro se parties.

A continuance of the initial date may be approved by the Court. *Boatright v. Wise Cty. Dep't of Soc. Servs.*, 64 Va. App. 71, 79-81 (2014).

**Note: See Procedures for Civil Actions Manual for continuing a trial date. If continuing case outside of 90 days by an agreed continuance, it is recommended that the order state that the 90 day requirement is waived.**

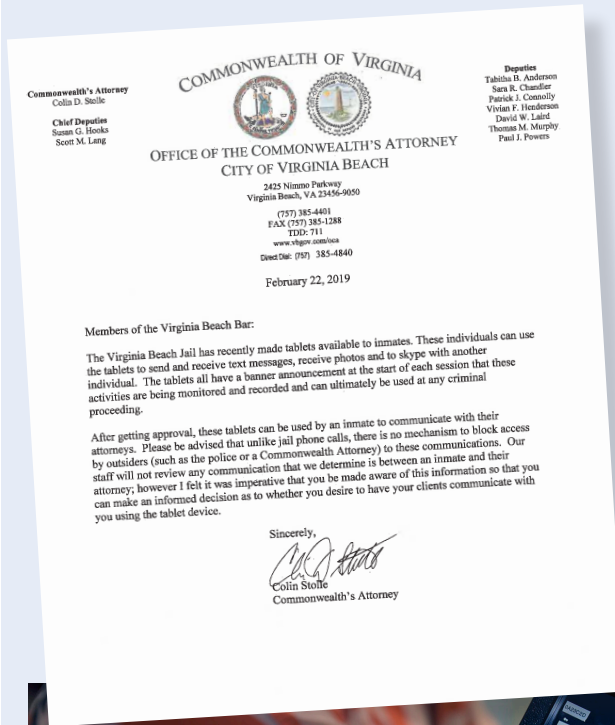

## LETTER FROM COLIN STOLLE, VB CWA REGARDING INMATE USE OF TABLETS IN JAIL:

The Virginia Beach Jail has recently made tablets available to inmates. These individuals can use the tablets to send and receive text messages, receive photos and to skype with another individual. The tablets all have a banner announcement at the start of each session that these activities are being monitored and recorded and can ultimately be used at any criminal proceeding.

After getting approval, these tablets can be used by an inmate to communicate with their attorneys. Please be advised that unlike jail phone calls, there is no mechanism to block access by outsiders (such as the police or a Commonwealth Attorney) to these communications. Our staff will not review any communication that we determine is between an inmate

and their attorney; however I felt it was imperative that you be made aware of this information so that you can make an informed decision as to whether you desire to have your clients communicate with you using the tablet device.

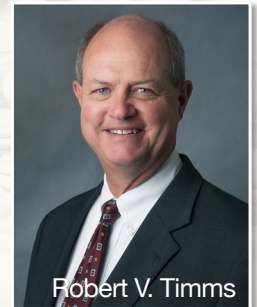

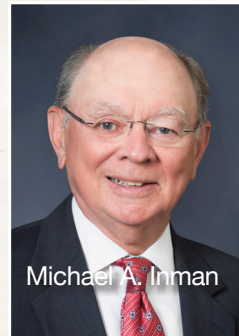

## NOTICES FROM THE VIRGINIA BEACH SHERIFF'S OFFICE

### SECURING JURORS' VEHICLES

Following a recent issue with jurors' cars being vandalized, the Virginia Beach Sheriff's Office has implemented an option for securing jurors' vehicles during trial (after jury selection is completed). If requested, the Sheriff's Office in consultation with the presiding judge can – on a limited basis – provide a secured parking area for jurors' vehicles while serving in the Virginia Beach Courthouse. Counsel may request secured parking from Court Security if they have reason to believe there is a threat to safety, security or the integrity of the trial. Dedicated, unsecured jury parking will continue to be provided during jury selection, etc.

The system records all visits and communications that take place on the tablets and there is not a way for us to turn that feature off. For that reason, please be sure to use the phone system or an in-person visit for your clients to ensure attorney-client confidentiality.

To further enhance the safety and security of all persons conducting business in the Virginia Beach Courthouse, the Sheriff's Office will periodically conduct random security screenings of all normally "exempt personnel" entering the building including, but not limited to, attorneys, court reporters, volunteers and anyone who has been granted a pass to bypass the screening process. This will not include or affect Courthouse staff whose permanent work assignment is located within the Courthouse complex. ## CIRCUIT COURT INFORMATION FROM THE INTRODUCTION TO COURTS CLE; ENFORCEMENT OF DUTY JUDGE DOCKET BRIEFING RULES

*Practice tips from the Circuit Court By: Amy H. Jones, Staff Attorney*

### The “3 R’s” for success in circuit court

In December, I was honored to have the VBBA ask me to speak at its Introduction to the Courts CLE. While the CLE was directed towards new attorneys, I thought some of the information provided might be helpful to attorneys who have been practicing for a while. Like the traditional “3 R’s” for success in school, there are 3 R’s that apply for success in circuit court.

**The first R is read.** Read the Code. Read cases. Read what you submit. Read the court’s manuals on its website. At a minimum for divorce proceedings and civil orders you submit, following those concepts will save you a lot of time and trouble. The vast majority of orders we return are because of inconsistencies in the body of the order, or non-compliance with the requirements of the court’s procedure manuals. In divorces, decrees are frequently inconsistent within themselves, and/or with the parties’ agreement, and/or do not contain current support notices with all required information. Everyone is under time pressure so the tendency is just to “sign and send,” but in the long run it will save you more time if you take a few minutes to review paperwork before submitting it.

Reading the court’s online manuals – most of which are only a few pages – can also save you a lot of time and headaches. The majority of procedure questions I receive are readily answered by these manuals. Taking a look at these can save you the time of contacting me to ask what to do, and waiting for me to have a chance to get back to you.

**The second R is realize.** Realize the law clerks and I really do not want to return orders for corrections. If we can accurately determine what was intended and the necessary correction is small, we try to make handwritten changes so orders can be entered. Also, realize that it’s not helpful to assert in response to a rejection that this order has been entered before. Often it turns out that there is a difference between the prior file and the current one that is material to the court, but not to counsel, or that counsel didn’t recognize. As well, with so many local courts close together, it can be difficult for counsel to know that Virginia Beach entered the prior order, as opposed to another court. In any event, an order that was entered and perhaps should not have been does not give us the ability to forever waive applicable requirements.

**The final R is be reasonable.** The law clerks and I try to help as much as we can, but we cannot do your legal research for you. We are frequently away from our desks for our various duties, and we get a LOT of email and phone contact – maybe more than you would expect. So, please give us time to respond, and we always try to do so within 24 business hours (unless we are out of the office). Finally, if you want to track the status of your order, the law clerks and I are probably the worst resource to use, because there are four of us who review a lot of orders. That makes it very unlikely both that you will get the person who reviewed the order, and that they will remember it. Your best bet is OCRA (Officer of the Court Remote Access, currently free), which gives instant access 24/7.

### Reminder about Duty Judge Docket briefing and filing rules

The court has experienced increasing problems with compliance with the rules for filing motions and briefs for Duty Judge Docket matters. Examples include filing a binder of materials the afternoon before a hearing, and filing a motion an hour and a half before a hearing. The deadlines for filing are in place to give the judges time to become familiar with the issues and arguments, so they are prepared to make efficient and effective use of the time available for the hearing. As a result, counsel are reminded that opening briefs or memoranda must be filed at least 14 days prior to the hearing, with any opposition filed at least 7 days prior to the hearing. Motions that do not include briefs must be filed 5 business days prior to the hearing. Failure to comply with these requirements may result in the matter not being heard. As a reminder, all rules for the hearing of motions are contained in the Motions Dockets Procedures Manual on the court’s website ([www.vbgov.com/courts](http://www.vbgov.com/courts)).
